CONTINUATION SHEET

1. QUESTION: This project calls for sealing of all pavement cracks larger than 3/16" from approximately Station 3+50 to Station 56+25. Do you have any specs for this work, ie. cleaning of the joints, material types, etc. ?

ANSWER: Before placing sealant, all cracks shall be cleaned of debris to a depth of 1 inch minimum to ensure a clean, dry channel and to ensure adhesion between sealant and asphalt. Use a hot-pour sealant conforming to ASTM D6690.

2. QUESTION: The Specifications for Pavement Markings appear to allow thermoplastic or painted markings. Are painted pavement markings going to be allowed on this project?

ANSWER: Contractor shall provide thermoplastic pavement markings.
